C.O. Guest Caller Training Scholarship Program

- Purpose:** The purpose of this program is to help improve the quality of calling within the North Texas Callers Association by awarding a Caller/Cuer Training Scholarship either annually, or at the discretion of the Board.
- Amount:** The scholarship fund will pay up to \$500.00 toward the tuition and associated expenses, to an approved caller/cuer training class or school of the recipient's choice.
- Eligibility:** After one year's active membership in the NTCA, all members are eligible to apply for the scholarship; except for the members of the Scholarship Committee.
- Application:** Application for consideration as a recipient of a scholarship will be made on the standard form available from the NTCA Secretary, Computer Services, or any member of the Scholarship Committee.
- Selection:** The selection of the scholarship recipient shall be made by the Scholarship Committee based on all factors concerned, e.g., potential, financial need, personality, desires, recommendations, etc.
- Administration:** Administration of the program and the selection and awarding the scholarship(s) will be by a committee of four Full Member callers.
- Applicant:** The applicant will make application on the approved form. The completed form will be delivered to the Scholarship Committee Chairman by the date designated by that committee.
- A. All applications will be considered confidential. These applications will be retained by the committee for a period of one year.
 - B. The application must contain all the required information.
 - C. Scholarships awarded must be used within one year from the date awarded.
 - D. An extension of six months may be granted if submitted in writing with just cause shown.
